

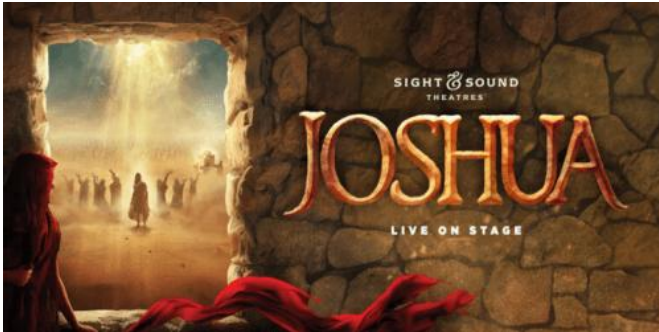
## "Joshua" at Sight & Sound Theatre
